MINUTES OF THE MEETING OF

THE 23rd ANNUAL GENERAL BODY MEETING OF FOIR HELD ON 8TH JUNE, 2022

VENUE: "GULMOHAR" CONFERENCE HALL

INDIAN HABITAT CENTRE, NEW DELHI

- 1. At the outset, Hony Vice Chairperson, FOIR/ Chairperson, CERC welcomed the members to the meeting of the General Body of FOIR.
- 2. Welcoming all the members for the General Body meeting, Hony. Chairperson, FOIR/ Chairperson CCI expressed his appreciation for the active participation of the members in the activities of FOIR. He made a special mention of the contribution of Shri P. K. Pujari, Chairperson CERC/Hony. Vice Chairperson FOIR in taking the vision of FOIR forward.
- 3. Delivering his opening remarks, Hony Chairperson FOIR/ Chairperson, CCI stated that FOIR was conceived as a platform for sharing of experiences by the regulatory authorities of infrastructure sectors in India. While current membership comprises sectors of electricity, airports, petroleum and natural gas, ports, competition commission, telecom and insolvency & bankruptcy, FOIR is also happy to welcome new members to FOIR who are from other sectors such as Real Estate Regulatory Authority, Punjab and Food &Safety Standards Authority of India. He also added though Andhra Pradesh ERC has decided to withdraw from FOIR, he was happy to note that Kerala ERC who had previously withdrawn from FOIR have rejoined FOIR looking at the value of FOIR to them. He also informed the members that the Governing Body had decided that SEBI and RERA in other States (other than Punjab which has already joined) be approached to become members of FOIR.

4. He also stated that in the past 1 year, FOIR, through its working group had recommended cross-sector collaboration on 5G initiated by TRAI. This initiative is being taken forward so that the end consumers can reap the benefits of intersectoral collaboration.

AGENDA 1: CONFIRMATION OF THE MINUTES OF 22ND ANNUAL GENERAL BODY MEETING

Deputy Chief (RA), CERC, updated the members about the action taken on the minutes of the 22ndAnnual General meeting of the FOIR and requested for the approval of the minutes. The General Body approved the Minutes placed before them.

AGENDA 2: CONSOLIDATED REVISED RULES OF FOIR.

- 1. Deputy Chief (RA), CERC apprised the Forum that the Governing Body in its 49th meeting had approved certain amendments in the Rules of FOIR and directed that the proposed amendments be taken to the General Body for ratification. Accordingly, amendments are proposed in the Rules of FOIR to
- i) enable collection of membership fees on pro-rata basis from the month of joining by new members in FOIR till March of the Financial Year.
- ii) to replace the word "Chairman" with "Chairperson".
- iii) to carve out a provision to induct other Infrastructure Regulatory Bodies in the General Body and Governing Body under the category of "State Electricity Regulatory Commission" without any change in the number of Members
- iv) to remove the phrases referring to "Zones" and "first Auditor "as they are no longer relevant.
- 2. After discussion, the aforesaid changes to the Rules & Regulations of FOIR were approved and the respective "Resolution" was duly endorsed by the Members.

Accordingly, the amendments will be filed with the Registrar of Societies for necessary updation.

AGENDA 3: MEMBERSHIP IN FOIR:

- 1. Deputy Chief (RA), CERC informed the General Body Members that while Food Safety and Standards Authority of India (FSSAI) and Real Estate Regulatory Authority (RERA), Punjab had joined as new members of FOIR, Kerala State Electricity Regulatory Commission (KSERC) who had initially withdrawn from FOIR couple of years back has re-joined the Forum. In addition, she also apprised the General Body that Andhra Pradesh Electricity Regulatory Commission (APERC) has requested for discontinuation of their membership in FOIR, as they are already a member in the Forum of Regulators (FOR). The members were informed that APERC has not participated in any events of FOIR during the FY 2021-22 and therefore did not pay the membership fees, due to which the General Body was requested to approve the waiver of the overdue fees.
- 2. While the General Body members welcomed the new members viz., FSSAI and RERA, Punjab and appreciated the joining back of KSERC as member of FOIR, they also opined that FOIR Secretariat may write to APERC to re-consider their decision of withdrawing from FOIR.

AGENDA 4: RECONSTITUTION OF GOVERNING BODY

1. Deputy Chief (RA), CERC, briefed the members about the Rules & Regulations of FOIR regarding composition of the Governing Body. The Chairpersons or Members of Regulatory Bodies/Authorities are nominated as Hony. Chairperson/ Hony Vice-Chairperson/ Hony. Member of the Governing Body based on their seniority, provided they have at least one-year service remaining in their organization. They will continue to be in the Governing Body as long as they hold the office in their respective Institution. Based on the above norms, the proposed constitution of the Governing Body for 2022-2023 was presented. It was proposed

- that Shri B.S. Bhuller, Chairperson, AERA would take over as Hony. Chairperson of FOIR, after Chairperson, CCI demits office. The General Body was also apprised that the vacant posts in the Governing Body pertaining to Central Infrastructure and Finance sector were also proposed to be filled in.
- 2. The members noted that the same is in accordance to the Rules of FOIR and approved by the Governing Body. The re-constituted Governing Body for 2022-2023 as approved by the Governing Body is **at Annexure II.**

AGENDA 5: ACCOUNTS RELATED MATTERS:

a) Budget of FOIR for the F.Y. 2022-2023.

Deputy Chief (RA), CERC explained the salient features of the proposed budget for the F.Y. 2022-2023. Hony. Chairperson FOIR/Chairperson CCI stated that the programs should be conducted online as well as offline to rationalize the expenses. After detailed deliberations, the General Body approved the budget for the F.Y.2022-2023.

b) Audited Accounts for the F.Y. 2021-2022.

- 1. Dy. Chief (RA), CERC informed that the Audited Accounts were not qualified by the Auditors. She briefly explained the salient features of the Audited Accounts for the F.Y. 2021-2022. She also detailed the necessary resolutions to be approved by the General Body relating to the Balance Sheet and Income expenditure as also utilization of earmarked funds.
- 2. After discussion, the General Body approved the Audited Accounts of FOIR for the F.Y. 2021-2022 alongwith the Resolutions.

c)& d) Re-appointment of Auditor for the F.Y. 2022-2023 and tax consultant for filing the Income Tax Return for the F.Y. 2022-2023.

The General Body Members approved the re-appointment of the Auditor (viz. M/s R.S. Gupta & Co., CAs) (3rd year of their tenure) and that the Tax Consultant (viz. M/s R.K. Raman & Co., CAs) for the F.Y. 2022-2023 (4th year of their tenure).

e) Re-investment of fixed deposits

Deputy Chief (RA), CERC informed the members regarding the maturity of fixed deposits amounting to Rs. 3.98 Crore with Union Bank of India, Connaught Place, New Delhi, in July 2022 and that as per the information gathered by FOIR Sectt. from few PSU Banks, the reinvestment will be made based on the highest rate of interest being offered amongst the PSU banks. The members unanimously approved the same.

AGENDA 6: UPDATE BY FOIR CENTRE, IICA – PRESENTATION BY FOIR CENTRE, IICA

1. DG&CEO, IICA greeted the AGM members on behalf of IICA and appreciated the partnership between FOIR and IICA. He pressed upon the need for strengthening the capacity building further that will be necessary for the intellectual growth of FOIR. DG IICA then requested Director, FOIR Centre, IICA, to carry forward the proceedings for Agenda no. 6 and all the sub-items.

a) Activities conducted during 2021-22

A detailed presentation (**Annexure III**) on the item-wise activities was made by Director FOIR Centre, IICA. The General Body noted the activities of FOIR Centre, Indian Institute of Corporate Affairs.

b) Activities proposed for 2022-23

FOIR Center, IICA proposed various activities to be conducted during the FY 2022-23 as under:

- 2. The above activities have already been incorporated in the FOIR budget and the General Body has approved the same in the previous agenda. Hony Vice Chairperson, FOIR/Chairperson, CERC stated that the subject/theme of each capacity building program is to be finalized as per suggestions received from FOIR Members/ Subject expert/FOIR Sectt. After discussion, the General Body approved all proposed activities.

c) Annual Report of FOIR for 2020-21 & 2021-22

The Annual Reports of FOIR for the FY 2020-21 & for FY 2021-22 were presented by FOIR Centre, IICA and the General Body approved the same.

AGENDA 7: CROSS SECTOR COLLABORATIVE REGULATION BETWEEN TELECOM REGULATOR (TRAI) AND ELECTRICITY REGULATORS (ERCS)

Deputy Chief (RA), CERC apprised the members that based on discussion held in the 21st AGM, a Working Group on "Cross Sector Collaborative Regulation between Telecom Regulator and Electricity Regulators" was constituted. Thereafter, the report of the Working Group was deliberated in the 49th Governing Body meeting. As decided by the Governing Body, the report was also discussed during the 78th and 79th meetings of Forum of Regulators (FOR) wherein the FOR recommended various action points on the report which included that SERCs may come up with regulations on revenue sharing between DISCOMs and consumers for income other than core business; telecom service providers may approach SERCs, if there is a need, so that a single bill can be issued for multiple connections issued to the telecom service provider and payment for all the commutative bills may be done at one go. Further, telecom operators may also approach SERCs for a separate tariff slab for energy consumed by the telecom service providers.

AGENDA 8: ANY OTHER ITEM

- 1. Some of the members underscored the need for discussion on substantial issues during the AGM. Hony Chairperson, FOIR clarified that substantial issues such as cross sectoral aspects between telecom and electricity sector collaboration have been discussed in the Governing Body meetings. Hony. Vice Chairperson, FOIR/Chairperson, TRAI also opined that FOIR may explore more cross sector collaborations between Ports sector, Airport sector, metros and Smart city projects with Electricity and Telecom. Some Members suggested to engage in discussion on issues of competition in electricity and other sectors vis a vis quality of supply and consumer centric issues.
- 2. Chairperson, KSERC added that after a gap of two years they decided to re-join FOIR as they felt that they were missing out on the research and academic activities being conducted by FOIR with the assistance from IICA.
- 3. Some of the AGM members also suggested circulating minutes of the Governing Body meetings, proposed studies, completed reports and all correspondences directly to all AGM members. To this Hony Chairperson, FOIR clarified that all such information is regularly uploaded on the FOIR website by the FOIR Secretariat and the same may be seen. It was, however, agreed that FOIR may intimate the AGM members through email at intervals regarding the important updates as available on the website. Hony Vice Chairperson, FOIR also appreciated that suggestion box (in the website of FOIR) may be created wherein any FOIR member may offer his/her suggestions.
- 4. On the suggestion that FOIR should have some budgetary provision for sharing of cost of travel of the FOIR members for attending AGM, Hony Chairperson, FOIR clarified that such provisions would have high financial implications. However, he suggested that it would be beneficial to organize future AGMs in a hybrid mode which may facilitate other members to attend the meeting virtually.

At the end, the members noted that Mr. P. K. Pujari, Chairperson, CERC/Hony. Vice Chairperson FOIR is due to retire on superannuation on 11th June, 2022 (this being his last General Body meeting), and placed on record their deep appreciation for the valuable contribution of Mr. Pujari in the activities of FOIR.

The meeting concluded with vote of thanks to the Chair.


